Topic 1: Welcoming new CAC members!

Topic 2: OHA Update

Rebecca Donnell provided an update on the Health Related Social Needs benefits and the Community Capacity Building Fund opportunity for community-based organizations.

Topic 3: Health Equity and Engagement Team Updates

Dr. Phyusin shared that the Health Equity and Engagement team has welcomed a new Community Engagement Portfolio Manager, Luci Longoria (she/ella/they). Luci will be responsible for providing direct support and leadership for the Community Advisory Council.

Christine Kan (she/her) has been promoted to serve as the Community Health Manager. She will be responsible for leading the CHIP/CHNA work.

Topic 4: Behavioral Health Ecosystem (Mindy/Phyusin)

Mindy and Phyusin shared a presentation on Health Share's Population Analysis, with a focus on the Behavioral Health/SUD population and the High Acuity clients. Mindy shared some high level data and what steps our CCO has taken in response to the High Acuity crisis; the work will only continue.

Topic 5: SHARE Update

Maria shared an overview of our SHARE process, and what we are able to accomplish in 2023. We are planning to bring the CAC and CIMAC together again in April to kickstart the SHARE 2024 process again, by taking our collective learnings from 2023. Maria also shared an update on our partnership with the Oregon Public Health Institute, who is SHARE grantee from 2023.
